Rebate Applications must be received by the Energy Service Dept. within 180 days of purchase/installation date.

Please allow 6-8 weeks for rebate processing. All information must be filled out completely to receive rebate. Incomplete or inaccurate applications will either delay payments or be denied.

A copy of your invoice/receipt. Invoice must include address, work proposed (R-values prior to upgrade & proposed R-value), sq ft. of conditioned ceiling area, and insulation type. (Unconditioned areas shall not be included)

NOTE: Insulation rebates are for existing residences or facilities only; new construction does not qualify. The rebate amount shall not exceed the purchase price. To receive a rebate, the existing insulation level must be less than R30 as determined by an insulation contractor or customer verification and must be increased up to a minimum of R30 and/or above. Today's Florida Energy Efficiency Codes require a minimum of R30/R38 Ceiling Insulation; however, R38 or higher is recommended. The insulation shall be installed in a residence or facility receiving electrical service from CEC.
