### Have Solar? Let Us Know.



Florida law requires utilities like Clay Electric to track the amount of electricity members send back to the grid from customer-owned alternative energy systems.

Right now, thousands of Clay Electric members have solar systems powering their homes. When those systems produce more energy than needed, the extra power flows back into our distribution system. A special meter tracks this, so you get credit for the energy you return.

If you already have solar or are planning to install a system, you must sign an Interconnection Agreement with us. If you're planning to upgrade or expand your existing system, we need to know that, too. This isn't just a co-op policy — it's required by the state.

Letting us know helps keep our system safe, ensures accurate billing, and makes sure you receive the proper credit for any excess power your system produces.

## **Costs forecast triggers Power Cost Adjustment increase**

Data collected by Seminole Electric Cooperative, Clay Electric's wholesale power provider, suggests a spike in costs associated with providing reliable electricity. It's led your cooperative to implement a rate increase, which will first be reflected on August member billing statements in a Power Cost Adjustment (PCA).

Beginning in August, members using the industry household average of 1,000 kWh/month will now pay approximately \$148, an increase of \$10. The additional amount each member pays monthly varies based on how much electricity is used.

The increase is largely driven by the forecasted rise in the cost of natural gas, which remains the dominant and most reliable fuel source for generating electricity in Florida. Alternative sources simply don't yet offer the consistency or scale needed to meet daily demand across the state.

### Who's eligible?

To apply, you must:

- Be at least 22 years old.
- Live in a home served by Clay Electric.
- Have a high school diploma or GED.
- Be enrolled at or registered for an accredited college or trade school for spring 2026.
- Not be a previous recipient of a Clay Electric scholarship.
- Not be a Clay Electric employee.

### **How it works**

Applications will be reviewed by an independent panel of judges. They'll score each one based on:

- Financial need (50%)
- Leadership and/or community service (20%)
- Educational goals and career plans (30%)

Applications must be received by **Sept. 12**. If you're selected, we'll also need proof of your spring 2026 enrollment by **Dec. 12**. Miss that deadline, and the scholarship will go to the next eligible applicant — so mark your calendar.

The PCA is a separate line item on each Clay Electric billing statement, which reflects either an increase or decrease in the co-op's wholesale cost of power. When the cost of power is greater than the amount included in the base rate, the PCA is a charge; when the cost is less, the PCA is a credit. In 2023, Clay Electric was able to lower the cost of your power four times through PCAs.

Remember, members receive power at cost as Clay Electric is a not-for-profit cooperative. The Power Cost Adjustment ensures you're only paying real-time wholesale power costs on a monthby-month basis.
